- d) She should not communicate directly or indirectly to any person, any information, which has come into her possession in the course of her duties.
- e) She shall not accept any brief from any person in any case of proceedings in any Court in which she appears or act on behalf of the University.
- f) She shall also render Legal Opinion on such matters as and when referred to her concerning the University business within the stipulated time.
- g) She shall handle the cases herself without transferring the responsibility to any other Junior Advocate.

The Professional Fee payable during the period of his appointment as UAS Legal Counsel shall be as prescribed by the University.
